Cannonball Bike Run 2018 (CBR-2018) is a potent formula that can cause highly increased levels of adrenalin and should only be administered as directed.

What are the active ingredients of CBR-2018?

Who should take CBR-2018?

PAYMENT SCHEDULE CBR 2018

Cannonball Bike Run 2018 provides an easy payment schedule to allow entrants to spread the cost of entry.

Your initial deposit amount to be paid with return of this Application Form will vary according to the time when you make your application for entry. The table below shows when the various staged payments are due.

For example you apply for entry before December 1st 2017 then you need only pay a deposit of £599. If you apply for entry after December 1st your deposit amount should be £599 + £500 for a total of £1099 and so on.

CANCELLATION

If you need to cancel and do so prior to March 1st then a maximum of 30% of the total entry fee will be forfeited and any subsequent payments that you made to us will be returned to you.

TERMS AND CONDITIONS

1] GENERAL REQUIREMENTS

You must hold a current valid motorcycle driving license and a valid passport (with at least six months left to run).

2] THE EVENT

Entry into Cannonball Bike Run (the Event) will be granted to those participants who have returned a completed an Event Application Entry Form with the appropriate entry fee and have received an approved notification of acceptance from the Organisers. The Organisers reserve the right to refuse any application for entry without giving any reason. The payment of the deposit is your acknowledgment of acceptance of the Event's Terms and Conditions.

3] PAYMENT / CANCELLATION

A deposit amount as detailed in the enclosed Payment Schedule is required to secure entry into the Event. The full balance due is payable no later than March 1st 2018. Bookings received after March 1st 2018 must be accompanied by full payment. The Organisers reserve the right to cancel or postpone the Event or any part thereof should circumstances arise which make such action desirable or necessary. If it proves necessary for us to cancel the Event prior to commencement, a full and immediate refund will be issued or where possible an alternative date offered. If cancellation or curtailment of the Event is necessary due to natural disaster, flood, fire, strike, storm, other acts of god, terrorist attack, civil unrest or any other circumstances beyond the control of the Organisers no refund will be made. After the commencement of the Event, the Organisers will not make any refund of the entry fee or pay compensation to you if you are unable to continue in the Event for any reason whatsoever. If you do not manage to complete any part of the route and are unable to stay at the provided venues you will not be entitled to any refund of the entry fee.

4] INSURANCE / LIABILITY

Participants are responsible for ensuring that the machines used in the Event are properly licensed and insured for use on the public highways in all countries detailed in the itinerary. Participants are responsible for ensuring that they have a minimum of third party insurance cover for the whole Event. You must confirm that you have obtained appropriate insurance for your participation and be prepared to supply copies of such insurance, personal injury and third party insurance, and insurance of your machine and your other possessions. The Cannonball Bike Run (the Event) is operated by Wildside Adrenalin Sports Ltd (the Organisers). Wildside Adrenalin Sports Ltd carries a comprehensive £10,000,000 tour operator's liability policy. Notwithstanding this you have to sign a full disclaimer document relating to your participation in the Event prior to the start. If you are in any doubt about signing the full disclaimer document you must request a copy from the Organisers prior to making your application for entry. Your failure to accept and sign the full disclaimer document is not a valid basis on which a refund will be made. Travel insurance is not included in the entry fee. You are strongly advised to take out such insurance cover for the duration of the Cannonball Bike Run. Participants are responsible for ensuring that they have mechanical breakdown recovery insurance for their participation in the Event which covers all countries detailed in the itinerary. The Organisers accept no responsibility for repatriation of machines or participants regardless of circumstance. The Organisers decline liability in any accident caused by or to participants and their machines during the whole of the Event. The Organisers also decline any liability for any breach of the laws and regulations of any country detailed in the itinerary. Participants shall be held responsible for any accident or breach of the laws in which they may be involved and shall declare to the Organisers particulars of any such incident from which liability may arise and shall have no claim against the Organisers arising out of any act or omission of the Organisers, their servants, agents or officials during the course of the Event.

5] MEDICAL RESTRICTIONS

You will be riding in varied conditions and in changing climates, often for (very) long periods. If you have any medical conditions, which could be adversely affected by strenuous exercise or are in any doubts about your health, or taking any medication, you must get clearance from your doctors before returning the application form. Although you may be fit to take part, there may be relevant medical information about which we should know e.g. allergic reactions, diabetes, epilepsy etc. It is important that we know about any potential problems.

6] HOTELS

Hotels, where included as part of the entry fee, are offered subject to availability. The Organisers reserve the right to alter hotel accommodation to that of an equivalent grade where necessary.

8] SURCHARGES

The Organisers reserve the right to apply a surcharge where currency fluctuations or other circumstances beyond our control deem this necessary.

9] TRAVEL DOCUMENTS

Participants are responsible for ensuring that all travel documents required eg. passports, visas are valid and effective.

10] TRANSPORT OF BIKES

Participants will be responsible for making their own arrangements to have their motorcycles at the Event start location. The Organisers may suggest optional transport services and/or advice to assist participants to reach the start and/or return from the finish. No responsibility for failure of these 3rd parties to perform or be on time will be accepted by the Organisers.

11] FORCE MAJEURE

The Organisers are not responsible if they cannot fulfill their obligations or if delay occurs resulting from cases of fire, earthquake, epidemic diseases, cyclone, flood, storm, aridity, strike, lightning, war in the country, revolution, civil war, terrorist activities and similar troubles, blockade, embargo, confiscation and expropriation, and in other cases defined as Force Majeure by the laws and regulations or for any reason or situation beyond their will power and control.

12] PUBLICITY

By entering the CBR 2018 as a sponsored entrant you agree that you will provide a 'Go-Pro' camera for your own filming, 5 hours of filmed footage and a 30 second video blog daily diary. You must also be prepared to carry event/sponsor logos on your motor bike, agree to be included in any filmed material of the CBR and participate in press interviews where requested.

12] VALIDITY

This is a legally binding contract. These rules and your participation in the Event are governed by English law, and you submit to the jurisdiction of the English courts.
